**S.O 345.**-In exercise of the powers conferred by section 15 read with section 23C of the Mines & Minerals (Development & Regulation) Act, 1957 (Central Act No.67 of 1957), the Government hereby direct that the following proviso shall be added to clause (vi) of sub-rule (1) of rule 56 of the Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules , 2016; namely:-

***"Provided that in emergent situation, the Government, in the interest of Major Developmental Projects of Indian Railways and National Highway Authority of India (NHAI), subject to statutory clearances including environmental safeguards, may grant Short Term Permit to their Principal Executing Agencies based on the certification of the concerned authorities upto 31.12.2021."***


