> "Provided that in emergent situation, the Administrative Secretary, Mining Department, in the interest of Major Developmental Projects of Indian Railways, National Highway Authority of India (NHAI) and Airports Authority of India (AAI), including their subsidiary companies such as IRCON, KRCL and NHIDCL, subject to statutory clearances including environmental safeguards, may grant Short Term Permit to their Principal Executing Agencies based on the certification of the concerned authorities upto 31.12.2021."
