In case any officer feels aggrieved with the position assigned to him in the Seniority List, he may file a review petition, as per the relevant provisions of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. The review petitions, if any, containing facts, as have not been considered or as have come to light now and which have a material bearing on the issue of determination of seniority, should reach this office within a period of one month from the date of issuance of this order failing which the above Seniority list shall be deemed to have attained finality.

The Final Seniority list, shall however be subject to the final outcome of the pending court case(s), if any.

The date(s) of birth as well as category recorded/indicated against the officers in the Final Seniority List, shall not be taken as authentic, and, shall be subject to the verification from the Service Book/Matriculation Certificates/ other relevant record as prescribe under norms.


