Sanction is hereby accorded to the reimbursement of medical expenses incurred by Mr. Peer Ghulam Mustafa, Drill Operator Grade-II, Geology and Mining Department for the treatment of his son at Artemis Hospital, Gurugram, Haryana, beyond the amount admissible under the AB-PMJAY SEHAT scheme, in relaxation of Rule 6-A of the J&K Civil Services (Medical Attendance and Allowance) Rules 1990 subject to following conditions:-

- a) Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted to the extent of rates as applicable to such items/procedures at AIIMS New Delhi.
- b) All relevant medical bills/vouchers are verified from relevant Medical Authority of the hospital where from treatment has been undertaken.
- c) Essentiality Certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- d) Certificate from the Competent Medical Authority (Director Health Services/Principal GMC/other) is obtained to establish the genuineness of the treatment availed in the said hospital.
- e) Dependence of the patient on the official is established before reimbursement of the claim.

Sanction is also accorded to the reimbursement of medical expenses incurred by the official for treatment of his son within the Union Territory, in terms of Rule 5 of the J&K Civil Services (Medical Attendance and Allowance) Rules 1990 and subject to the conditions laid down therein.


