Taking up of work in mining affected areas under DISTRICT MINERALFOUNDATION TRUST & PMKKKY (the funds of District Mineral Foundation Trust took off from the year 2020-21 and as on date i.e. 31 Oct 2023 an amount of 50.92 crores towards the Trust in the J&K has been contributed since its inception out of which 20.15 crores were released for execution of 331 PMKKKY schemes)

G. The Production of Gypsum through JKML has increased from targeted production of 10,000MTS to 52,000 MTS per Month and is further expected to increase in FY 2023-24after renewal of lease of additional Gypsum blocks.

H. The JKML Corporation has recently received the approval from Ministry of Mines Govt. of India for reservation of Limestone Quarry Khrew. Exploratory drilling of bore-holes has been entrusted to Directorate of Geology & Mining sand the work is under process.
