Sanction is hereby accorded to the constitution of committee comprising of following for taking important decisions regarding the tendering process, RESCO model of implementation, viability gap funding and methodology of payment to the developer for installation of the Rooftop Solar Power Plants in the Government buildings of Mining Department:-

- 1) Director, Geology and Mining, J&K.
- 2) Additional Secretary to the Government, Mining Department.
- 3) Director Finance, Mining Department.
- 4) Managing Director, Jammu and Kashmir Minerals Ltd.
- 5) Deputy Director,(Planning) Mining Department.
- 6) Representatives of JAKEDA/REC/NHPC as co-opt member for technical advice.
- 7) Representative of DISCOM (JKPDCL/KPDCL).

The Terms of Reference:-

- i. The Committee shall monitor and supervise the mission of solarization of all Government Buildings in the Department for accelerated Solarization to attain saturation by or before December, 2024 as directed by the Prime Minister's Office (PMO).
- ii. The Committee shall advise an innovative ways for resource mobilization for successful implementation of the project in RESCO/Capex/Hybrid modes. They shall suggest source of funding through Finance Department/MNRE and other Funding Agencies like REC/other Financial Institutions.
- iii. The Committee shall recommend decisions regarding the RESCO tender and identification of executing agencies.
- iv. The Committee shall identify viable buildings and collect all major parameters like availability of rooftop and evacuation network, the total electricity load, sanctioned connected load as well as revenue budget spent on electricity bills be shared with JAKEDA.
- v. The Committee shall nominate Estates officers/In-charge officers for major Buildings where RESCO/Capex/Hybrid model shall be implemented.
- vi. The Committee shall hire Consultants/Technical Advisors for suggesting any initiative(s) required for acceleration of the Solarization of the Government Buildings in case of Departments having large number of Government buildings.
- vii. The progress of the Solarization shall be shared on fortnightly basis to the Science and Technology Department/JAKEDA.
